Dr. Carol Ulloa is the Director of the Comprehensive Epilepsy Center. She attended medical school at the University of Missouri-Kansas City. After completing her neurology residency at Boston University, she subspecialized in the fields of clinical neurophysiology and epilepsy during a two-year fellowship at New York-Presbyterian Hospital/Weill Cornell Medical Center. Dr. Ulloa then joined the faculty at Geisinger Health System in Pennsylvania for five years, where she served as Associate Director of Neurology. 
Colleen Lechtenberg, M.D.





Dr. Jaime Perales Puchalt is an Assistant Professor at the University of Kansas Medical Center. His background is in psychology and public health. In addition to conducting research in Spain, England and the United States, Dr. Perales Puchalt has collaborated with teams from other countries in the European Union and the Americas. With a primary focus on reducing Latino dementia disparities, his research has led to developing a dementia educational/recruitment tool for Latinos. He has also studied the risk of dementia and mild cognitive impairment among sexual and ethnoracial minorities. He is currently developing and testing the first dementia caregiver support text message intervention among





Dr. Hannah Katz is an Assistant Professor in the Department of Psychiatry and Behavioral Sciences at the University of Kansas Medical Center and a licensed psychologist in Kansas. She joined the faculty in 2020.

As a member of the Onco-Psychology Program at the National Cancer Institute-designated University of Kansas Cancer Center, Dr. Katz specializes in providing clinical services to cancer patients and their caregivers in the Hematological Malignancies and Cellular Therapy Division. She also is credentialed as a Health Service Psychologist by the National Register of Health Service Psychologists.

Dr. Katz earned a Doctor of Psychology degree in clinical psychology with a health psychology focus from the University of Denver Graduate School of Professional Psychology in 2019. She completed a predoctoral internship accredited by the American Psychological Association (APA) in 2018-19 and an APA-accredited postdoctoral fellowship focusing on onco-psychology at the University of Kansas Medical Center in 2019-20. Making Great Strides: Striving for Health Equity in Cystic Fibrosis Deepika Polineni, M.D., M.P.H.
Assistant Professor, Pulmonary, Critical Care, and Sleep Medicine



Dr. Deepika Polineni has a broad clinical/translational science background in adult pulmonary clinical and translational research with specific training and expertise in translational studies of modifier genes in cystic fibrosis (CF) lung disease. Dr. Polineni's training to date has included completing a pulmonary clinical fellowship focused on CF with subspecialty board certification, research employing basic science methodologies in human and murine airway specimens, and multi-center clinical and translational studies of CF. Complementary to genomic studies of the North American Cystic Fibrosis Gene Modifiers Consortium, Dr. Polineni developed a multi-center (US and Canadian) *in vivo* transcriptomic study of CF airway epithelia. These efforts yielded a biorepository of CF nasal lavage, mucosal biopsies, nasal epithelial

RNA from 152 people with CF. Dr. Polineni has developed a validation cohort biorepository of

59 people with CF (to date) at the University of Kansas Medical Center with ongoing NIH support.

Abiodun Akinwuntan, Ph.D., M.P.H., M.B.A., F.A.S.A.H.P.

Professor, Department of Neurology




Dr. Abiodun Akinwuntan became the school's sixth dean in January 2016. He previously served as associate dean for research at the College of Allied Health Sciences at Augusta University in Augusta, GA., where he was professor of physical therapy, ophthalmology, and neurology.

Dr. Akinwuntan received his bachelor's degree from the College of Medicine, University of Lagos in 1994, a master's degree and a doctoral degree in neurological rehabilitation from the Katholieke Universiteit Leuven (Catholic University of Leuven) in Belgium, in 2000 and 2004, respectively. He earned a postgraduate certificate in teaching and learning in higher education from the University


of East London, England, in 2005, and a master's degree in public health in 2012, followed by a master's degree in business administration in 2015 from Augusta University GA.

Dr. Akinwuntan is a world-leading authority on using virtual-reality technologies to improve daily living activities in neurologically impaired persons. Akinwuntan has collaborated extensively on several funded grants totaling more than \$15 million. He has authored more than 110 peer-reviewed publications and abstracts, mostly in reputable journals with high impact factors, and authored eight book chapters. He is also co-director of the Laboratory for Advanced Rehabilitation Research in Simulation.

Dr. Akinwuntan is a recipient of the prestigious United States Fulbright Scholarship to Nigeria in 2013 and a Fulbright Specialist Award to Iceland in 2016. He is the editor-in-chief of The Nigerian Journal of Medical Rehabilitation, an academic editor of PLOS ONE Journal, and a member of the editorial board for the Archives of Physical Medicine and Rehabilitation Journal. He is a member of the nomination and elections committee and chair of the research, discovery, and innovation committee of the Association of Schools Advancing the Health Professions. Akinwuntan is treasurer of the Midwest Deans Group and a member of the association's 2018 leadership development program.

Dr. K. Allen Greiner is currently Professor and Vice Chair of the Department of Family Medicine at the University of Kansas Medical Center (KUMC) in Kansas City, Kansas. He has a secondary appointment and teaches in the M.P.H and M.S. in Clinical Research Programs in the Department of Preventive Medicine and Public Health. Dr. Greiner completed an undergraduate degree in Anthropology from Brown University and medical school and a Family Medicine residency at the University of Kansas. In 2000, he completed a Primary Care Research Fellowship at the University of Kansas and a Masters in Public Health degree.

He is a practicing family physician and is the Medical Officer for the Kansas City, Kansas, Wyandotte County Unified Government

Health Department. He was an inaugural member of the KUMC Gold Humanism Honor Society and previously received a KU Kemper Fellowship Award for Teaching Excellence, the 2012 KUMC School of Medicine Early Career Achievement Award, the 2014 University Scholarly Achievement Award, and the School of Medicine 2018 Bohan Teaching Professorship Award.

Since 2002 Dr. Greiner has been one of two primary faculty advisors to the JayDoc Free Clinic, a medical student-run clinic for the uninsured in Kansas City. He directs the Kansas Patients and Providers Engaged in Prevention Research (KPPEPR) Network. This primary care practice-based research network serves as an important research laboratory for health studies and projects in rural and urban safety-net clinics across the state of Kansas. Over the last decade, the KPPEPR Network has been the primary recruitment setting for four separate National Institutes of Health (NIH) R01 intervention studies and an ongoing multi-year comparative effectiveness trial of weight-loss strategies in rural Primary care (PCORI funded, C. Befort, PI).

Dr. Greiner is Principal Investigator on a NIH National Cancer Institute funded R01 study evaluating the impact of multiple doses of implementation intentions interventions on colorectal cancer screening in urban safety-net clinics. In August 2017, he completed work after seven years of funding on an NIH U54 award supporting the Kansas Community Cancer Disparities Network. This Community Networks Program Center grant from the National Cancer Institute worked with Latinos and American Indians across the state and was one of 23 cancer health disparities centers across the US.

For the past seven years, he has directed or co-directed the community engagement program for Frontiers, KU Medical Center's Clinical Translational Science Institute. Through this program, he leads efforts to expand community-based research and to assure a strong infrastructure and community input into KUMC's bioscience activities. He is well versed in community-based participatory research (CBPR) methods and has worked to merge health services and access to care enhancements into his various research programs.

He has received federal and foundation grant support to study health information technology, health disparities, chronic disease management, health literacy, and patient health risk behaviors in rural and urban underserved community settings. Since assuming the directorship of the Research Division in Family Medicine 11 years ago, he has overseen growth from a total of three faculty to a current 25 faculty, staff and fellows.

Dr. Greiner's future plans include policy work and pursuit of funding for multilevel research in cancer control and prevention, health behaviors, and the social determinants of health.

Sally Maliski, Ph.D., R.N., F.A.A.N.

Dr. Sally Maliski has been the dean of the University of Kansas School of Nursing for five years. Prior to coming to the University of Kansas, Maliski was associate dean for academic and student affairs at the UCLA School of Nursing.

Dr. Maliski earned her Bachelor of Science in Nursing from the State University of New York at Albany. She received a Master of Science in Nursing from Russell Sage College in Troy, New York, and a doctorate in nursing from the University of North Carolina in Chapel Hill. She had postdoctoral fellowships in quality of life at the University of Pennsylvania and UCLA. Dr. Maliski was inducted as a Fellow in the American Academy of Nursing in 2010.

Dr. Maliski's research focuses on quality of life and cancer treatment-related symptom management among underserved populations. She has a strong commitment to reducing cancer health disparities and understanding the factors underlying such disparities via interdisciplinary teamwork. Dean Maliski's work has been federally funded and widely published. Hospice, oncology and free clinic primary care highlight her clinical experience.

**Lee Norman, M.D.**Secretary, Kansas Department of Health and Environment State Health Officer
Army State Surgeon of Kansas



Dr. Lee A. Norman is the Secretary of the Kansas Department of Health and Environment (KDHE), appointed by Governor Laura Kelly. KDHE has three divisions, including Health, Environment and Healthcare Finance, which includes the Medicaid program (KanCare) and the State Employee Health Plan.

Dr. Norman received his medical degree from the University of Minnesota, did his residency in family medicine in Texas and his aerospace medicine training in the United States Air Force at Brooks AFB in San Antonio. After serving in the USAF as a family physician, flight surgeon, and combat medicine instructor, he practiced medicine in Seattle for 20 years, also serving as a clinical associate professor at the University of Washington School of

Medicine. Dr. Norman has served as a chief medical office for over 26 years, most recently at the University of Kansas Health System and before that the Swedish Health System in Seattle, beginning in 1991. He is currently a clinical assistant professor at the University of Kansas School of Medicine. Norman is a past board member and Chair of the Puget Sound Blood

Center in Seattle and has served on the governing board of Heart to Heart International, a humanitarian organization based in Lenexa, Kansas.

In his military role, Norman is a colonel in the Kansas Army National Guard, stationed at Joint Forces Headquarters in Topeka, Kansas, reporting to the State of Kansas Adjutant General. As the State Surgeon of Kansas, COL Norman guides medical troop sustainment and training, health services support, force health protection, biosecurity, and serves as advisor and liaison to the Kansas Department of Emergency Management and Homeland Security. He is an advisor to the Kansas Intelligence Fusion Center. In 2018 Dr. Norman returned from a Middle East US Army deployment as the 35th Infantry Division Surgeon. In this role, he was the senior medical commander of over 12,000 U.S. soldiers encompassing three named operations - Freedom Sentinel, Spartan Shield and Inherent Resolve.

Additionally, Dr. Norman serves on the Defense Health Board as an advisor to the U.S: Secretary of Defense.

Dr. Steven Stites serves a dual role as vice chancellor for clinical affairs and senior vice president for clinical affairs for The University of Kansas Hospital Authority. He served as chair of the University of Kansas Medical Center's Department of Internal Medicine from 2007 to 2014. He also has served as senior associate dean for clinical affairs for the University of Kansas Medical Center, following ten months as acting executive vice chancellor.

As vice chancellor for clinical affairs, Dr. Stites reports to the university's executive vice chancellor, working to fully integrate our clinical departments into a wider-reaching health system and ensuring we have a strong strategic plan for educating future physicians and growing the academic

strength of our clinical programs. As senior vice president for clinical affairs, Dr. Stites reports to The University of Kansas Hospital Authority's chief executive officer and has responsibilities, especially in the area of clinical programs and practice development, as well as strategic planning and education. He will work closely with other members of the hospital's executive team and with The University of Kansas Physicians to implement the next phase of our clinical enterprise, which includes creating a wider health system.

Under Dr. Stites' leadership, the Department of Internal Medicine saw significant growth (e.g., six Internal Medicine divisions—pulmonary medicine, nephrology, cardiology, oncology, endocrinology and gastroenterology) and earned top 50 U.S. News and World Report rankings in 2013. The medical intensive care unit is one of the country's best, with a Beacon Award to its

name. In addition to his administrative responsibilities, Dr. Stites directs KU Medical Center's Cystic Fibrosis Center, having founded the adult CF program in 1994. It's now one of the larger adult programs in the United States, with more than 150 patients. His research areas include investigating different airway clearance methods for adult CF patients and how these affect the distribution of inhaled medicines. He has also written at length on the ways and means of developing mission-based funding for academic departments: the Educational Value Unit (EVU) system — specifically aligning salary support for faculty with each individual's educational responsibilities — which he published in 2005 has been adopted by several other institutions.

Dr. McGee has delivered numerous keynote addresses about diversity, fostering equitable and inclusive learning and working environments, leadership, unconscious bias and systemic racism.
